


Adolescent ASAM Alignment

✓ Ambulatory WM = DDAP is reviewing and gathering information

- DHS and DDAP are collaborating to develop a bulletin to address requirement for ASAM
 - Announce co-occurring enhanced services are to be provided in accordance with the criteria developed by ASAM.
 - Issue requirements for a co-occurring enhanced program.

Bulletin



- The bulletin will:
 - Provide guidance on establishing quality care delivery system for treatment of individuals presenting with co-occurring mental health and substance use disorders
 - Outline the need for all co-occurring enhanced services to be provided in accordance with ASAM criteria.



- Outcome Expectations
 - Adolescents, adults and young adults shall be treated by utilizing ASAM criteria.
 - Programs should assume that individuals coming into SUD treatment are likely to have co-occurring conditions and needs.
 - All programs must have an adequate service system to either assess and refer (co-occurring capable) to appropriate mental health services or provide services to individuals diagnosed with a co-occurring disorder to ensure the best clinical outcomes(co-occurring enhanced).
 - Utilize clinical knowledge, clinical practice and public policy to address the needs of the individual instead of "placement".

Why Monitor for ASAM?

Ensure Compliance with the SUD 1115 Waiver Requirements:

- Access to critical Levels of Care (LOCs)
- Use of evidence-based, SUD-specific patient placement criteria
- Use of nationally recognized SUD-specific program standards to set provider qualifications for residential treatment facilities



Monitoring Tasks

Determine alignment with the ASAM Criteria, 3rd Edition, 2013 appropriate to each level.

Ensure providers are enrolled within the Medical Assistance (MA) Program at the appropriate ASAM LOC.

Develop an on-going monitoring process for MA Providers and all contracted providers consistent with the new criteria.

Develop monitoring tools to include a review of the facility's infrastructure and record review to ensure compliance with the latest edition of ASAM Criteria.



Monitoring ASAM - Tool

 Infrastructure review – the focus is on examining policies and procedures

- Application two-part process
 - Interview
 - Record review
